Bid scope for mowing at Mooresville Graded School District  
Contract Date: January 1, 2016 - December 30, 2018

**Service shall be provided bi-monthly except March and November (one time each). This will factor to a total of sixteen (16) actual cuts.**

**1. South Elementary School (839 S. Magnolia St.):**

Front yard, parking lots, around mega units, back yard, pipe line to the creek and around playground structure.

**2. HS Annex "B" Lot (160 S. Magnolia St.):**

All sides (including bank) and islands of parking lot, along service road, along entrance areas adj. Center Ave.

**3. Park View Elementary School (217 W. McNeely Ave.):**

Front, sides, playground and all areas with sidewalks.

**4. NF Woods Technology (574 W. McLelland Ave.):**

Front, side and parking lots, rear and softball areas, including large bank behind "C" Bldg. 1 time per month.

**5. East Mooresville Intermediate School (1711 Landis Highway):**

Front, around field #1 and field #2, Kitchen/Gym area, Rear and playground and 150 roadside along fencing.

**6. Mooresville Intermediate School (1438 Coddle Creek Rd.):**

Complete front to fencing, around fencing, between classroom wings, behind fire lane and parking lots.

**7. Mooresville Middle School (233 Kistler Farm Rd.):**

All front areas, down and along service road, around softball field and between classroom wings.

**8. Rocky River Elementary School (483 Rocky River Rd.):**

Main drive from Rocky River Road, front of school, inside and outside play area, along access drive and around parking areas.

**9. Any Schools As Determined by the Dir. of Maintenance:**

Hourly cost, per tractor, for snow/ice removal.
